


Value of Tasmania's International Exports by Country 2012-13 to 2014-15

Caveats/advice for users

While the ABS recognises the importance of international trade statistics to a wide variety of users, the quality of very detailed data (e.g. eight digit exports and ten digit imports, by port, by state, by country) cannot be guaranteed, as resources are not available to assure data quality at this level. The detailed data released is largely 'as reported' to Customs.

FOB Value: The value of goods measured on a free on board (fob) basis includes all production and other costs incurred up until the goods are placed on board the international carrier for export. FOB values exclude international insurance and transport costs. They include the value of the outside packaging in which the product is wrapped, but do not include the value of the international freight containers used for transporting the goods. Information on the CIF and FOB values for imports is reported only once for each Customs import declaration, regardless of how many separate lines and/or commodities that declaration may contain. As a result, any declaration with more than one line will not necessarily correctly allocate CIF and FOB values to the individual commodities.

Country of final destination: For exports, 'country' refers to the country of final destination of goods at the time of export.

State of origin: For exports, State of origin is the Australian State in which the final stage of production or manufacture occurs. It does not necessarily equate to the State in which the goods were loaded onto the international carrier.
