G. The number of 'Red Tape Issues' received by the Red Tape Reduction Coordinator from members of the public during the 2020-21 financial year.

There were 19 new red tape priorities identified in 2020 and reported in the Red Tape Audit Report, reflecting reform priorities across various sectors ranging from construction to the sharing economy. These red tape issues were identified through an extensive consultation process with industry and the business community, with 14 originating directly from industry associations, and 5 from other government agencies' key stakeholder consultation processes.

Please note, the Red Tape Audit Report is prepared on a calendar year basis, so this information is from the 2020 report. The report for the 2021 calendar year is not yet complete and so it is not possible to collate the information on a financial year basis.

In addition to these broader red tape reform issues, the Red Tape Reduction Coordinator also received 77 red tape matters from individual small businesses during the 2020-21 financial year. These were individual matters that were addressed on a case-by-case basis and did not require, or show a need for, a broader industry-based reform.
