1.4 Defined terms





IMPORTANT NOTES:

- A. The Contract Information Table:
 - Sets out the key variable contract details relevant to the application and operation
 of the Conditions of Contract to the procurement. (NOTE: The Conditions of
 Contract are incorporated by reference into the Contract).
 - May modify the Conditions of Contract as they apply to the delivery of the Supplies and in other respects.
 - May include additional terms and conditions of contract which will apply to the Contract.

Goods and/or Services to be supplied:

The goods and/or services (the **Supplies**) to be supplied by the Supplier to the Principal in accordance with the Contract are as follows:

Goods: Not applicable. The Supplies do not include Goods.

Services: The production and delivery of high quality conceptual images of a stadium and facilities at the preferred site as identified in the "Southern Stadium Analysis", for use by the Principal in internal and external preliminary stakeholder presentations.

A more detailed description of the goods and/services being procured is included in the Specification.

Specification applicable to Supplies:

The Supplies must comply with, and also where applicable be delivered in accordance with, the following specification (the **Specification**):

- 1. The Supplier is to conceptually design a 23,000-27,000 seat capacity stadium and facilities in southern Tasmania at the preferred site identified in the preliminary feasibility site options assessment (refer Contract No. NR 1227 between the Principal and the Supplier), including full rendering and high definition photography of the nominated site as part of the concept development.
- 2. The Supplier must deliver three (3) high resolution, 'magazine quality' aspirational rendered images, consisting of the following:
 - a. Image 1 Angle low level view from the river in a westerly direction towards Hobart city and Mount wellington, highlighting the stadium and waterfront district;
 - b. Image 2 Angle high level view in a westerly direction towards Hobart city and Mount Wellington; and
 - c. Image 3 Angle mid level view in a north easterly direction down Macquarie Street, Hobart with the Cenotaph in the image.
- 3. The Supplier must deliver the final images in PDF and jpeg format, to the satisfaction of the Principal's Representative (acting reasonably), by no later than 28 February 2022, or other date agreed between the parties in writing.

Required cover:

The policy must cover liabilities arising out of, or in connection with, the performance of the Contract by the Supplier, including liabilities in respect of:

- (a) personal injury to, or the death of, any person (excluding a person who at the time of the injury or death is defined as a worker of the Supplier under any Law relating to workers' or accident compensation insurance); and
- (b) loss, destruction or damage to any property.

If the Supplier is supplying Services, the public liability insurance policy must indemnify the Principal for any vicarious or other legal liability that the Principal may have in respect of any willful or negligent act or omission of the Supplier or any Supplier's Personne

Period of insurance:

The period commencing on the date of the Contract until the Supplier has performed all of its obligations under the Contract, or the date on

which the Contract is terminated (whichever first occurs).

claims arising out of a single occurrence.

under the Contract.

A Contract Special Condition is taken not to be inconsistent with another provision of the Contract if the Contract Special Condition and the other provision of the Contract are both capable of being complied with.

Contract Special Conditions:

- 1. The Supplier agrees and warrants:
 - a. that the Specified Personnel piloting or in any way operating remotely piloted aircraft equipment (including an aerial drone system) are subject to the necessary licences and training and that the piloting or operation of remotely piloted aircraft equipment will be undertaken in compliance with all licence conditions and requirements; and
 - b. that the Services will be undertaken and delivered in compliance with all applicable regulations, standards and legislative requirements including the Civil Aviation Safety Authority (CASA) regulations governing commercial drone piloting.
