

# Message from the Premier and Minister for Trade and Major Investment, and Chair of the King Island Response Team, Jeremy Rockliff.

Last week we held the final meeting for the King Island Response Team for the year.

We understand that many on the island are waiting for news on the negotiations between Saputo and potential buyers of the King Island Dairy.

The Tasmanian Government will continue to keep the community informed of the progress.

Saputo's Paul Davies informed the meeting that it would be his last as he was moving on to another role in the New Year. I want to thank Paul not only for his contribution to KIRT in recent months, but also for his long-standing commitment and engagement with the King Island Dairy and community. Paul will be replaced on the Response Team by Trevor Stones, who many on the island would know as the site manager at King Island Dairy.

Saputo provided an update on how it is managing animal welfare considerations as part of transition planning for the farms it operates. Its herd management plans will ensure it complies with industry standards for animal care and handling practices.

It is heartening to hear that another major employer on the island, Group Six Metals, has agreed on a restructure for the company which should see the mine continue to operate into the future.

The meeting discussed the opportunity to work with the tourism industry on the island and West by North West Tourism to look at a number of opportunities to strengthen visitation to the island and increase its offering. This work will align with the King Island Tourism Strategy to ensure sustainable growth for the industry on the island.

Initiatives for tourism could include upgrades to infrastructure, particularly public parks and

spaces and important amenities, a look at gaps in the industry and possible responses, as well as a sustainable events framework to bring more people to the island.

It was great to hear from the Mayor about the approval for two important developments on the island, one for workers and another for visitors to the island. Both will help to boost the local economy while building happens and then by providing space for workers and visitors into the future.

Late last week a number of Government representatives were on the island for the Drought Reflection and Resilience Workshops and it was great to hear that a large number of Islanders were part of the sessions. With recent rains the island is certainly in a much better position ahead of the summer and many of the farmers are better prepared should we see more dry conditions over the remainder of the season.

I want to wish everyone a Merry Christmas and hope you enjoy a well-deserved break. It is important that we all remain positive and there are good things to come.
