Minute to the Premier

SUBJECT: CARTELA RESTORATION PROJECT – GRANT OF \$1 MILLION


Premier's notation:

Recommendation:

That you:

- 1. Note that on 10 February 2023, the Tasmanian Government announced that it would provide a grant of \$1 million to the Steamship Cartela Trust to assist with the design and construction of a ship lift to be installed in the Franklin area, to pave the way for the restoration of the Cartela and other wooden boats in the future.
- 2. Note that the trust has since determined that Franklin is not a viable option for the ship lift, primarily due to the difficulties securing a suitable site, and the challenges of obtaining the various regulatory approvals which would be required.
- 3. Note that the trust has identified the slipways at Napoleon Street, Battery Point, as an alternative and has requested that Government agree to an amendment to the committed purpose of the grant, to allow for the restoration of the Cartela to be undertaken at this site.
- 4. Formally approve a grant of up to \$1 million to the Steamship Cartela Trust to assist with the restoration efforts to the Cartela on the terms and conditions as set out in Attachment 1 of this Minute.
- 5. Note that the grant is proposed to be payable in instalments, with the first instalment of \$112,000 to be provided to determine if it is feasible for the Cartela to be restored at an existing slipway at Battery Point, and for the trust to attempt to obtain the planning approvals which may be required to upgrade the slipway.
- 6. Note that if the trust is able to progress the Cartela restoration at Battery Point:


- the trust has advised the remaining \$880,000 should be adequate to fund the required upgrade of the slipway but not to complete the restoration of the Cartela
- the trust is unable to provide costings to complete the Cartela restoration



Current Situation:

- On 10 February 2023, the Tasmanian Government announced that it would provide a grant of \$1 million to the Steamship Cartela Trust to assist with the design and construction of a ship lift to be installed in the Franklin area. This funding was committed to pave the way for restoration of the Cartela, as well as support the restoration and maintenance of other wooden boats in the future.
- The trust originally advised that the estimated cost of the ship lift was \$1.5 million with the trust required to raise the balance funds from other sources including philanthropic support.
- Since the commitment of the \$1 million grant was announced, the trust has been undertaking research to determine if there is a suitable location for the ship lift in the Franklin area.
- Following detailed investigation, the trust has determined that undertaking the restoration of the Cartela at Franklin through building and locating a ship lift as part of a wider Maritime Heritage Precinct is not a viable option, due to:
 - the difficulty in securing a suitable location for the ship lift
 - challenges in securing the required regulatory approvals for the ship lift
 - o the conservation zone for the Franklin River may prevent some restoration works
 - Castle Forbes Bay can be difficult for larger tall ships to navigate.
- The trust also advises that the existing commercial slipway and drydock options in Tasmania are not viable to restore the Cartela due to the high daily costs, with the restoration program for the vessel's wooden hull likely to take more than two years.
- The trust advises that one of the existing slipways at 44 Napoleon St, Battery Point, could be a possible alternative option for the restoration of the Cartela's hull. If this is feasible it would be the trust's intention for the refurbishment of the vessel's superstructure to be undertaken at Franklin, where possible.
- The slipway at Battery Point is owned by the Hobart City Council s27

- The Battery Point slipway has historically been used for vessel's smaller than the Cartela. The trust is proposing that <u>\$27</u> review the slipway and provide a feasibility report on the remedial action and costs required to bring it to the necessary standard to hold the Cartela and allow its restoration.
- The trust has also obtained preliminary planning advice that if it is feasible for the slipway to be upgraded to accommodate the Cartela, as the new cradle would be bigger, this may require a planning permit which would be discretionary due to its heritage listings.
- The trust believes that if the Battery Point slipway is able to be upgraded, in the future it will be used to restore and maintain many other wooden boats, due to strong demand for this type of facility.
- The trust has requested the Government's consideration to approving a change of purpose of the \$1 million as originally committed. **527** it is also seeking an upfront instalment under the grant of \$112,000 to be used for the following purposes:
 - o feasibility report on the requirements for the Battery Point slipway upgrade
 - investigation into suitability for the Cartela to be towed from Franklin to Battery Point, the methodology and costs
 - planning advice, and costs, to obtain any necessary approvals to upgrade the slipway.
- The trust believes that it has strong support from the local community for the Cartela to be restored at Battery Point. **s27**
- If the feasibility report determines that an upgrade to the slipway could accommodate the Cartela, and the trust is able to obtain any required planning approvals, the trust is seeking to use the remaining grant funds to complete the upgrade of the slipway, to tow the Cartela from Franklin to Battery Point, and for any balance funds to be used towards the cost of restoring the Cartela's hull.
- The trust advises that the full cost of restoring the Cartela cannot be determined until the ship is lifted out of the water and its hull inspected.
- In March 2023, State Growth staff completed an inspection of the Cartela at Franklin where it has been moored for several years. It is confirmed that the vessel is in very poor condition with the superstructure almost entirely gutted. Photos of the current condition of the Cartela are provided at Attachment 2.



Background:


The Cartela is a historically important Tasmanian vessel and was built in Battery Point in 1912.

The Cartela has a long history, from being leased to the Royal Australian Navy in World War I, to transporting Tasmanians across the River Derwent after the collapse of the Tasman Bridge in 1975, and more recently hosting tourists, school groups and wedding parties. The Cartela was most recently operated on the Derwent as a commercial vessel by the Navigators Group of companies (owned by the ______).

In 2012, the Navigators Group donated the Cartela to the Steamship Cartela Trust with the intent that the vessel be restored. The Steamship Cartela Trust was established for the sole purpose of the promotion, restoration, and preservation of the Cartela.

Item 3 (clause 3.1): Payment method for the Grant

The Grant is payable in instalments, as follows:

Instalment I: up to \$112,000 - to be used for the elements of the Approved Purpose defined at Item I (a), (b) and (c).

Instalment 2: up to 888,000 - to be used for the elements of the Approved Purpose defined at Item I (d) and (e).

Instalment 3: any balance of the Grant funds up to 1 million - to be used for the element of the Approved Purpose defined at Item I (f).

Payment of each Grant instalment is subject to the Recipient satisfying all applicable Conditions precedent set out in Item 4.

Item 4 (clause 4.1): Conditions precedent to payment of the Grant

With respect to:

Instalment I: upon execution of this Deed, and the provision of:

- (a) a proposal from a Qualified Consultant to complete the Approved Purpose defined at Item I (a) that must acknowledge and meet the requirements of the Feasibility Study and Feasibility Report as defined in the Glossary;
- (b) a proposal from a Qualified Consultant to complete the Approved Purpose defined at Item I (b) that must acknowledge and meet the requirements of the Feasibility Study and Feasibility Report as defined in the Glossary; and

(c) evidence that the Recipient has sufficient funds, including funds available under Instalment I, to complete the Approved Purpose defined at Item I (a), (b), and (c).

Instalment 2: the provision of:

- (a) the Feasibility Report which confirms the Hunter Slipway situated at 44 Napoleon St, Battery Point can be upgraded to enable the Cartela to be slipped and the hull restored at the site;
- (b) the Feasibility Report which confirms the suitability of the Cartela to be towed from Franklin to the Hunter Slipway;
- (c) a copy of a legal agreement between the Recipient, the Hobart City Council and the current tenant of 44 Napoleon Street, Battery Point that includes:
 - i. agreement that the Hunter Slipway is to be upgraded to enable the Cartela to be slipped and the hull restored at the site;
 - ii. agreement that the Hunter Slipway will be made available to the Recipient for the required duration of the Cartela restoration program; and
 - iii. any rental arrangements.
- (d) copies of all statutory approval documentation required to undertake the Approved Purpose defined at Item I (c);
- (e) a budget to complete the Approved Purpose defined at Item I (d);
- (f) copies of contracts for any builders or other businesses engaged to complete the Approved Purpose defined at Item I (d);
- (g) a budget for the Approved Purpose defined at Item I (e);
- (h) evidence that the Recipient has sufficient funds, including funds available under Instalment 2, to complete the Approved Purpose defined at Item 1 (d), and (e);
- (i) evidence of expenditure incurred for the Approved Purpose to date, supported by tax invoices for any individual expenditure amounts in excess of \$5,000; and
- (j) a statutory declaration signed for and on behalf of the Recipient by a duly authorised officer or employee of the Recipient confirming that all of the information provided by the Recipient in support of its claim is true and correct.

Instalment 3: upon the successful completion of the Approved Purpose defined at Item I (a), (b), (c), (d), and (e), and the provision of:

(a) evidence of expenditure for the Approved Purpose defined at Item I (f), equivalent to the amount of the instalment payment sought.

Once each Condition precedent has been met to the satisfaction of the Grantor, payment of the related Instalment will be made on receipt of a valid invoice from the Recipient.

Item 5 (clause 5.1): Grant Account

Item 6 (clause 6.1): Agreed Plan for carrying out the Approved Purpose

The Agreed Plan is the carrying out of the Approved Purpose in accordance with the recommendations in the Feasibility Reports.

Item 10 (clause 10.1): Outcomes

The Recipient must ensure that the Approved Purpose has the Outcomes of:

- (a) the successful completion of the upgrade to Hunter Slipway;
- (b) the Cartela having been slipped at the Hunter Slipway; and
- (c) the Cartela's hull restored at the Hunter Slipway.

Item 11 (clause II.I): Reporting requirements

In addition to the reporting requirements outlined in Item 4, the Recipient must provide to the Grantor:

- (a) a Progress Report within twenty (20) Business Days of the end of each Relevant Reporting Quarter, for each Relevant Reporting Quarter until the completion of the Approved Purpose.
- (b) a Final Report and Financial Acquittal no later than 30 June 2025.

The Recipient agrees to provide any additional information or reports as reasonable requested by the Grantor.

All information and reports must be provided within twenty (20) Business Days of the Grantor's written request.

All information, submissions and reports must be in a form and of a substance satisfactory to the Grantor.

Item 12 (clause 12.1): Insurance

The Recipient agrees to ensure an adequate level of insurance is maintained for:

- (a) the Cartela; and
- (b) undertaking the Approved Purpose.

Item 13 (clause 13.1): Special terms and conditions

The Recipient agrees:

- (a) to ensure that any interest received and/or accrued on the Grant Amount is to be used for the Approved Purpose;
- (b) to participate in any funding evaluation that may be undertaken by the Grantor;
- (c) that any cost overruns are the responsibility of the Recipient;
- (d) that if for any reason the Recipient is unable to proceed with the Approved Purpose, the grant funds will not be made available for any alternative Cartela restoration projects;
- (e) that the Grantor is not committing to any future funding for the restoration of the Cartela; and
- (f) to recognise the Grantor's assistance when promoting the project, including but not limited to information placed on the Recipient's website and social media accounts, media releases, media launches and in media interviews. In such instances the phrase "This project is supported by the Tasmanian Government through the Department for State Growth" must be adopted.

GLOSSARY

For the purposes of this Deed the following terms have the meaning defined below:

Relevant Reporting Quarter (Quarter) means the quarters ending:

- (a) 30 September;
- (b) 31 December;
- (c) 31 March; and
- (d) 30 June,

in each year until the completion of the Approved Purpose.

Feasibility Study means a comprehensive assessment that includes:

- (a) evaluation of practicality;
- (b) detailed costings;
- (c) a risk assessment and risk management plan;
- (d) resource requirements;
- (e) recommendations.

Feasibility Report means a report on the results of the Feasibility Study that:

(a) can be relied upon by the Grantor.

Qualified Consultant means a person or business that is commissioned by the Recipient to provide a written Feasibility Report that:

- (a) is suitably qualified for the work they are undertaking;
- (b) holds adequate professional indemnity insurance; and
- (c) is independent of the Recipient.

Hunter Slipway means the slipway site located at 44 Napoleon Street, Battery Point.

Final Report means a report that demonstrates that the Approved Purpose has been completed, underpinned by evidence.

Financial Acquittal means a report in respect of the Approved Purpose that includes:

- (a) paid tax invoices for any individual expenditure amounts in excess of \$5,000;
- (b) a statement that all funding received was expended on the Approved Purpose in accordance with this Deed, dated and signed by a duly appointed representative of the Recipient; and
- (c) details of income and expenditure in respect of the Grant, showing the Recipient's cash and/or in-kind contributions, which must include a definitive statement as to whether the accounts are true and fair, dated and signed by a duly appointed representative of the Recipient.



- The Trust has submitted the application for the Planning Permit, which was recently
 advertised in the Mercury on 23 January 2025. Any representations in relation to the
 Planning Permit need to be made by 7 February 2025.

- Whilst it was envisaged that the shiplift would be designed to be used for the maintenance of a number of wooden boats, its first application would be the restoration of the Cartela.

 - The difficulty in securing a suitable location for the ship lift.
 - Challenges in securing the required regulatory approvals for the ship lift.

- The trust has received the first grant instalment, and the feasibility studies for the Battery Point slipway have been undertaken by external consulting engineers. These studies were provided to State Growth on 3 December 2024.
- Whilst State Growth will be required to complete a detailed review of the consulting engineers' reports before providing advice to Government, it appears that it is feasible for the Cartela to be towed and slipped at Battery Point.
- Regarding planning, the trust advises that although there would be no change to the existing use of the slipway, the Cartela is larger by length and tonnage than currently allowable and therefore an application needs to be made to the Hobart city Council for an exemption. The trust has advised that it will shortly submit the application to the Council and that this process will take 42 days.

- The trust also advises that the cost of restoring the Cartela cannot be determined until the ship is lifted out of the water and its hull inspected.
- The ability of the trust to complete the restoration will be dependent upon being able to raise the required funding.



Current Situation:

The Community Infrastructure Fund grant of \$175 000, provided to the Steamship Cartela Trust (Cartela Trust) to support the restoration work on the Cartela, was due to be completed by 30 June 2020. Two instalments totalling \$126 000 have been fully acquitted.

Payment of the final instalment of \$49 000 was made to the business in December 2020 with a revised project completion date of 30 June 2021. A Grant Deed Variation was signed to enable this to occur.

The Cartela Trust advised the department on 15 June 2021 that the completion date of 30 June 2021 could not be achieved, and a second Grant Deed Variation was signed extending the completion date to 31 December 2021.

However, given the regional significance of this project, your approval is requested to provide funding of \$1 million to the Steamship Cartela Trust to allow this project to progress under your Ministerial discretion.

As part of the restoration, the Cartela Trust says it plans to work with service providers to provide Shipwright courses to create new skills pathways for Tasmanian workers.

The Cartela Trust also reports that it has received interest from interstate parties that would look to use the ship lift for their own restorations once the Steamship work is complete, potentially creating a future income stream as well as opportunities for skilled workers.



It should be noted that completion of this project is estimated to cost \$1.47 million, plus estimated operational costs of \$97,230 annually, and it is reliant on the project receiving other funding as outlined below:



The Department of State Growth would administer this grant in accordance with the Treasurer's Instruction FC-12- Grant Management via a grant deed.



An immediate payment upon signing of the grant deed will be made to facilitate urgent repair and monitoring works on the steamship. However, further milestone payments will be subject to the following risk mitigation strategies:

- Acquittal of the previous grant funding under the Community Infrastructure fund.
- A new project plan including project milestones and completion dates must be submitted.
- External funding to be confirmed.

Background:

The Steamship Cartela Trust was established in March 2012 when the Cartela steamship was donated by the Navigators Group of Companies (owned by the) to enable full restoration of the vessel.

The objective of the Cartela Trust, stated to be on behalf of and for the benefit of the people of Tasmania, is to restore the vessel to full (historical) working order, for it to be financially self-supporting, and to deliver a world class tourism experience.



Since 2013, the Tasmanian Government has provided \$493,000 in grant funding to support restoration efforts, \$27

A summary of this funding is provided below.

- \$60,000 in 2012 was provided to assist with due diligence studies and to purchase the Cartela's original steam engine.
- \$143,000 in 2016 was provided under the Tasmanian Community Fund (with a further \$75,000 provided by the Australian Government) to assist with refurbishment costs of the steam engine. It is the Department's understanding that this project remains incomplete.
- \$175,000 in August 2017 was allocated from the Community Infrastructure Fund. This
 project remains incomplete and has not yet been acquitted (see further information
 below).
- \$115,000 in December 2017 from the Department for the purposes of ongoing work related to the renovation project. This included \$30 000 for outsourcing the development and implementation of a Sponsorship Fundraising Plan, with a heavy emphasis on private funding thereafter. The Sponsorship Fundraising Plan was written however is yet to be implemented.

Community Infrastructure Fund

On 3 August 2017, the Cartela Trust was approved for funding of \$175,000 under the Community Infrastructure Fund.

The funding was provided to assist with the costs associated with the purchase of a barge, towage to Hobart, and raising the vessel from the water to advance restoration works.

Initially this project was scheduled to be completed and funding was due to be acquitted by 30 June 2020. Payment of the final instalment of \$49,000 was made in December 2020 with a revised project completion date of 30 June 2021.

While two instalments totalling \$126,000 have been fully acquitted, the final payment of \$49,000 has not yet been acquitted. In January 2023, the Department approved a third Grant Deed Variation to vary the date for the completion of the Approved Purpose from 30 June 2021 to 30 June 2023.
