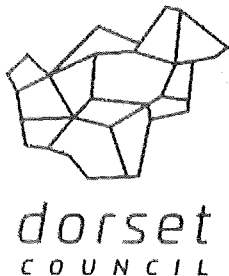



DERBY COUNCIL DEPOT – CEASE WORK AND VACATE

Further to my telephone discussion with Dwayne Griffin on Wednesday 27 May 2020, I refer to my previous letters regarding the unauthorised and illegal construction of a council depot on Crown land at Briseis Hole, Derby. I write to you again in disappointment and frustration at the disregard of the council to adhere to the expectations and directions of the State.

I have now been informed of, and provided with witness statements and photographic evidence that the new council depot site was accessed by either council staff or contractors on 12 May 2020, despite my previous written instruction and phone conversations, including a verbal commitment from yourself to vacate and cease all access to the site on 26 March 2020.

Specifically, on 26 March 2020, I wrote to you and, amongst other things, directed that the council cease works and occupation of the site immediately, given that the depot had been constructed without approval and encroaches upon an existing mining lease.

On 9 April, I again wrote to you to cease works. I had also verbally told you to vacate the site and cease all works during the teleconference between yourself, the Parks and Wildlife Service, and the Director of Mines.

On 5 May, another letter was sent to you directing that you cease works and stop accessing the site. You have acknowledged receiving the three letters.

This continued disregard for my direction is deeply concerning, and I am uncertain how much clearer I need to be to ensure that this unauthorised access and use stops. This matter is serious as the depot has been constructed without building and planning approvals, or any authorisation by the State. I, and Mineral Resources Tasmania, have reiterated the seriousness of this issue, particularly given the concerns raised by the existing mining lease holder.

I would also like to draw your attention to your obligations regarding WHS, and that the structure/site does not have building approval and therefore cannot be considered a safe workplace for your staff or contractors.

Hi Jason,

I have read the article.

The Mayor is not correct in his assessment but clearly hopes to have the issue put aside based on his comments. The Mining Lessee has no intention of adjusting the Mining Lease boundary a second time. As it is he has some of his immediate resource for extraction compromised due to the further encroachment.

Now that I have been to the site and reviewed the operations there is a strategic resource of sand and aggregate which is important for the state which should not be further impacted by the depot activities.

I will provide additional information from our visit later in the week however, of significant concern is the new water main that has been put in across the mining lease and that the sewerage (French drain) is on the mining lease. Regardless, should these should have been done by TasWater if there was a legal building approval? The lease holder was not consulted.

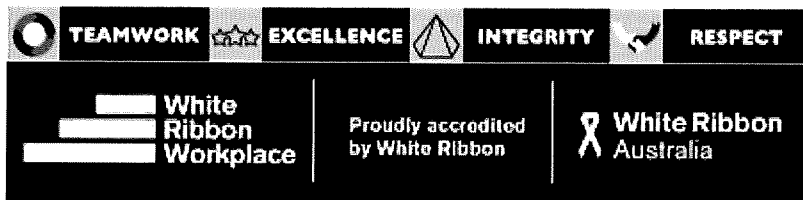

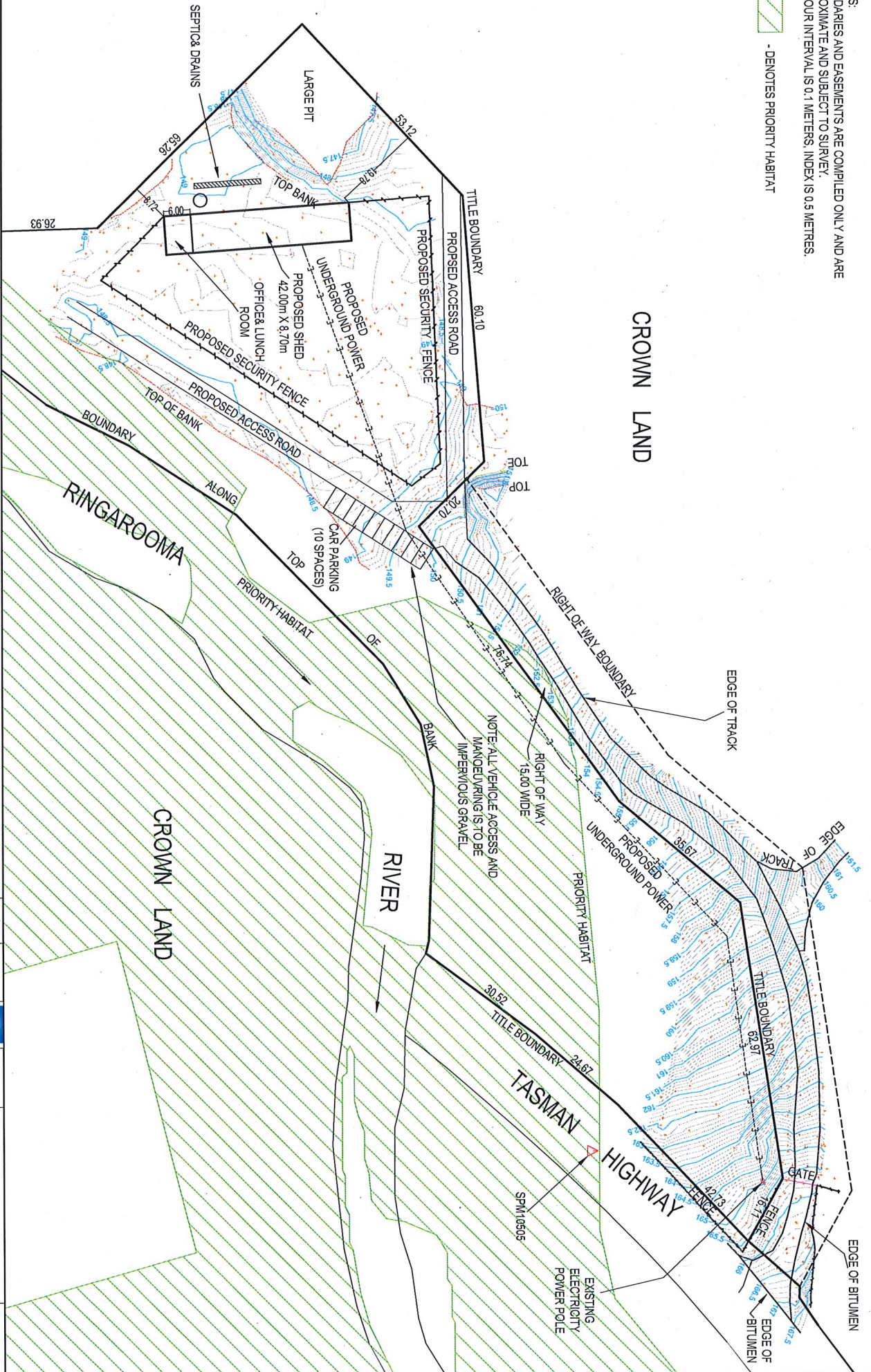

Hi Kevin and Clint,

I just want to let you know I have spoken to the father of the holder of mining lease 1M/2019 Mr Ron Hayes. He held the mining lease before it was transferred to his son Derek and his wife Kail. I spoke to him because I had a suspicion that the whole area under the new council shed and wash-bay is mullock from the old Briseis Mine. Ron confirmed this which means there is likely greater than 80 metres of material sand & basalt dumped in this location. Ron, who went to school in Derby and is now well into his late eighties has an extensive knowledge of the old mine. I thought this might be useful information if and when you are talking about potential sterilisation issues with Dorset Council and others.
